Home:School COVID-19 Agreement



The SCHOOL will do its best to:

- Provide an environment which has been risk assessed in response to the COVID-19 infection , Local Authority Risk assessment and government guidance
- Adhere to the social distancing rules as set out by the government as much as we reasonably can.
- Support your child's well-being, mental health and academic needs.
- Contact parents/carers if your child displays symptoms of COVID-19.
- Inform you if staff or children in your child's 'bubble' test positive for COVID-19 as this will mean you will all need to self-isolate for at least 14 days.
- Continue our approach to rewards and sanctions for children as set out in the Behaviour Policy as well as the expectations outlined in this agreement and the safety information sheets.
- If a child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe.
- Communicate through newsletters, text, email and the school website.

PARENTS and CARERS know and understand that:

- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school. I will get them tested and I will let the school know as soon as possible via telephone;
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately. I will get them tested and I will let the school know the outcome of the test as soon as possible via telephone.
- On my commute, and when dropping my child off and picking them up, I will adhere to the social distancing rules.
- On arrival at school, my child will remove any disposable face mask they are wearing, placing disposable ones in the bin or safely storing a fabric one.
- Apart from essential equipment including bag, lunch and outdoor clothing my child will not bring any other items into school with them.
- I understand that I will not be allowed onto the school site - all enquiries will be via telephone or email.
- I will read all letters/messages/emails that are sent home and check the school website regularly.
- I will inform the school of any changes to parents/carer and emergency contacts details.
- I will follow social distancing rules at all times. And ensure that my child arrives and is collected from school at the designated times.
- Ensure that my child follows social distancing rules outside of school hours to help keep the school community safe.

PUPILS I will do my best to:

- Follow the rules to prevent the spread of infection and all school behaviour rules.
- Clean my hands as soon as I go into school.
- Remove and dispose/ safely store face coverings.
- Tell an adult immediately if I feel unwell.
- Not bring extra items into school except for essential equipment, school bag, outdoor clothing and my lunch.
- Only enter the building when supervised by a teacher.
- Use my own equipment.
- Not mix with any other children outside my allocated 'bubble' group.
- Only enter the school site from the designated gate at the designated time.
- Follow the catch it-bin it-kill it rules, coughing and sneezing into elbow or tissue
- Regularly wash my hands using soap and water for 20 seconds or sanitise them.
- Follow teacher instructions and safety rules at all times to maintain the safety of myself and others.
- Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe.
